The item was produced with: PVC-P, TPE and POLYESTER FILAMENT YARN.

Avoid food-contact with the heads and outer surface of the hose.

Clean the hose before usage.

Use: delivery of water-based liquids, foodstuff, acid and alcohol up to 20%, which A, B, C simulants are provided for, for a maximum of 2 hours repeated contact at the maximum temperature of 70°C.

The item above mentioned is manufactured exclusively with substances (monomers, pigments, additives) indicated in the positive list of the current legislation.

The item respects the global migration limits and the specific restrictions in the following test condition:

Time of contact and temperature range: 2 hours at 70°C, not prolonged contact.

The overall migration limit, together with other specific restrictions which monomers and/or additives may be subject to, are respected in the above-mentioned condition of use.

The item respects the global migration limit, as well as the other specific restrictions to whom monomers and/or additive may be submit, in the condition mentioned above. This statement is supported by analytical tests conducted in accordance with Regulation n. 10/2011 and Ministerial Decree 21/03/1973 or on the basis of specific calculations in accordance with Directive 82/711/EC/, 85/572/EC, 85/575/EC and D.M. March 21st 1973. Calculations where made assuming that 1 kg foodstuff may come in contact with 6 dm² of the material.

Dual-use additives. The hose contains the following substances regulated by Regulation (EC) n. 1333/2008 (food additives) and 1334/2008 (flavourings) and subsequent updates: E470a Sodium, Potassium and Calcium salts of fatty acids.

The item is suitable for:


- any contact conditions at room temperature
